The Program's performance during December was positive and driven by gains in the Global Financials and Short-Term Interest Rates strategies.

Short-Term Interest Rates Strategy 0.47%

Positive performance was driven by long positions in Eurodollars. Short-term rates rose throughout the month as investors reacted to the revised expectation of less frequent interest rate increases in 2019.

Commodities Strategy -0.19%

The strategy's slight negative performance was primarily due to sharp price reversals in the natural gas markets. Prices rose over 35% in November and fell 33% in December. Existing long positions lost value as the strategy reduced its exposure.

Global Financials Strategy 1.55%

The strategy performed well across its investable markets. Positions in Japanese government bonds gained value from Japan's low interest rates, an uncertain economic outlook and a falling stock market. Short positions in the German DAX index were profitable. In currencies, short positions in the Canadian dollar profited as the currency fell due to tariffs and a sharp fall in energy prices.

Upside Capture Strategy -1.35%

This long-only strategy's performance reflected the negative performance of the global equity markets. Trade tensions, slowing growth and domestic political tensions drove market performance. Strategy losses were partially offset by profitable positions in gold and fixed income markets.
