The Fund's performance during October was negative, led by the Upside Capture Strategy.

**Short-Term Interest Rates Strategy      -0.26%**

The monthly performance was slightly negative, primarily due to losses in eurodollar positions. Long bond positions also registered losses as yields on interest rates in the U.S. moved higher.

**Commodities Strategy      0.38%**

Positive performance was driven by gains in the energy, grains, base metals and meat sectors. Short positions in crude oil futures gained value as prices fell to multi-month lows. Long positions in corn, soybean meal, wheat and cotton all posted gains. Long positions in aluminum benefited from rising prices. A short cattle position was also profitable.

**Global Financials Strategy      -0.45%**

Stock indices in the U.S. and Europe lost value while equities positions in Asian markets were basically unchanged. U.S. fixed income positions led strategy losses; gains from long positions in the German bund partially offset losses. Short positions in the U.S. dollar lost value as the dollar rallied and long positions in the commodity currencies also lost value as global energy and commodity prices fell. Long positions in the Japanese yen posted gains.

**Upside Capture Strategy      -0.67%**

The Strategy posted losses as global stocks, U.S. bonds and gold markets declined. Bond and interest rate prices fell throughout the month. Strength in the U.S. dollar caused gold prices to decline slightly.
