Comparison to U.S. Agg Index Jul 2020 – Jun 2025





- We believe the Fund's active management and sector diversification were key drivers of quarterly performance.




GPAIX Sector Exposure

Glossary

Beta: Beta is a measure of the volatility or systematic risk of a security compared to the market as a whole.

Bloomberg 1-3 year U.S. Treasury Index: Measures the performance of U.S. Treasury securities that have a remaining maturity of at least one year and less than three years.

Bloomberg U.S. Agg: A broad benchmark index that tracks the performance of U.S. dollar-denominated, investment-grade fixed-income securities, including government, corporate, mortgage-backed, and asset-backed bonds.

Correlation: A statistical measure of the degree to which two securities move in relation to each other. Correlations are computed as the correlation coefficient, which has a value that must fall between -1.0 and +1.0.

Down Capture: A statistical measure of the degree to which two securities move in relation to each other. Correlations are computed as the correlation coefficient, which has a value that must fall between - 1.0 and +1.0.

Sharpe ratio: (Average Return – Risk Free return) / Standard Deviation of return. The ratio measures the relationship of reward to risk in an investment strategy.

Standard & Poor's 500 Total Return Index: A weighted index consisting of the 500 stocks in the S&P 500 Index, which are chosen by Standard & Poor's based on industry representation, liquidity and stability. The stocks in the S&P 500 Index are not the 500 largest companies, rather the index is designed to capture the returns of many different sectors of the U.S. economy. The Total Return calculation includes the priceplus-gross cash dividend return. Investors cannot directly invest in an index and unmanaged index returns do not reflect any fees, expenses or sales charges.

Standard Deviation: A measure of investment risk that examines the variation of returns around the mean return. Higher volatility equates to higher standard deviation.

Up Capture: A statistical measure of an investment manager's overall performance in up-markets. The ratio is calculated by dividing the manager's returns by the returns of the index during the up-market and multiplying that factor by 100.
